In exercise of powers conferred under Rule 29(3) read with Rule 3 of Haryana School Education Rules 2003 Education Department, Haryana hereby permit to establish a new proposed school. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfil the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

The permission to set up a new proposed school is only 'In-principle' approval of the Education Department to allow applicant to initiate steps and provide infrastructure to set up the new proposed school.

Students should not be admitted only on this permission without getting recognition. The recognition is granted by the Department on fulfillment of prescribed norms as provided in Haryana School Education Rules-2003, in the interest of safety, health and welfare of students and other requirements.
